

CHOMPS SNACK BEARER SWEEPSTAKES

OFFICIAL RULES (“Official Rules”)

NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT’S CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

THESE OFFICIAL RULES CONTAIN A RELEASE OF LIABILITY AND LIMIT CERTAIN OF YOUR RIGHTS, INCLUDING THE RIGHT TO A JURY TRIAL, THE RIGHT TO PARTICIPATE IN ANY FORM OF CLASS, COLLECTIVE, OR REPRESENTATIVE CLAIM OR ACTION IN ARBITRATION AND LITIGATION, AND THE RIGHT TO CERTAIN REMEDIES AND FORMS OF RELIEF.

The Chomps Snack Bearer Sweepstakes (“Sweepstakes”) is sponsored by We Are The Chompkins, LLC (“Sponsor”), with offices at 453 Bayfront Place, Naples, FL 34102 and is administered by Twelve Thirty, LLC (“Administrator”).

- 1. SWEEPSTAKES PERIOD:** The Sweepstakes begins at or about 12:00 PM Eastern Time (“ET”) on September 24, 2026 and ends at 11:59:59 PM ET on October 31, 2026 (“Sweepstakes Period”). The Administrator’s computer is the Sweepstakes official clock.
- 2. ELIGIBILITY:** This Sweepstakes is offered only to legal residents of 50 United States and the District of Columbia (excluding Puerto Rico, Guam, U.S. Virgin Islands, and any other U.S. Territories) who are at least eighteen (18) years old (or the legal age of majority in the entrant’s state of residence if higher than age 18) at the time of entry. Employees, directors, officers, and agents of Sponsor, Administrator, and each of their respective parent companies, subsidiaries, affiliates, advertising and promotional agencies, and suppliers involved in the Sweepstakes (“Sweepstakes Entities”), as well as the members of each of their immediate families (defined as spouse, parents, children, and siblings) and persons residing in the same household (whether related or not) as such individuals are not eligible to enter or win. Void where prohibited or restricted by law.

Participation constitutes entrant’s full and unconditional agreement to these Official Rules and Sponsor’s decisions and interpretations, which are final and binding in all matters related to the Sweepstakes.

3. HOW TO ENTER THE SWEEPSTAKES:

- A. Entry:** No purchase or payment is necessary to enter the Sweepstakes and a purchase or payment does not increase or improve the chances of winning. During the Sweepstakes Period, an eligible entrant must visit chompssnackbearer.com (the “Website”) and submit their valid e-mail address. The entrant then must register by entering the information requested on the registration form, which may include without limitation: first and last name (initials are not permitted), complete mailing address (P.O. Boxes are not permitted), date of birth, telephone number, response to the written prompt “tell us about your special day,” and affirmation that the entrant has read and agrees to be bound by these Official Rules. Upon completion and submission of the registration form, the entrant will receive one (1) entry into the Sweepstakes.
- B. Limit:** Each entrant is limited to receiving one (1) entry per day during the Sweepstakes Period. If more than one (1) entry is received from the same person, telephone number,

or e-mail address in the same day, only the first entry received that day may be considered valid. For purposes of this Sweepstakes, a “day” is the twenty-four (24) hour period between 12:00 AM ET and 11:59:59 PM ET, except on September 24, 2026, on which a “day” will be the period between 12:00 PM ET and 11:59:59 PM ET.

NOTE: If accessing the Website via a mobile device, message and data rates may apply. Not all mobile telephone providers carry the service necessary to participate in this Sweepstakes. Entrants should consult their wireless provider’s pricing plans.

C. Restrictions. Each entry (including the entry form and all other writings, data, information, content, and other materials included in the entry) must comply with the following:

- i. It must be entirely the original work of the entrant; no portion of the entry may be created using any artificial intelligence tool or generator;
- ii. It must not infringe, misappropriate, or violate any intellectual property rights, privacy rights, publicity rights, or other proprietary rights of any third party; and
- iii. All information provided in the entry must be true, accurate, and correct in all respects.
- iv. It must not be created or submitted through any script, macro, or other automatic method.
- v. It must comply with these Official Rules and all applicable laws.
- vi. It must be suitable for publication to a general audience and must not contain anything that:
 - 1) is illegal, abusive, tortious, defamatory, pornographic, sexually explicit, obscene, libelous, invasive of another's privacy, hateful, or otherwise objectionable;
 - 2) promotes discrimination based on race, ethnicity, nationality, religion, sex, sexual orientation, disability, or age;
 - 3) promotes violence or unsafe or illegal activity;
 - 4) is threatening, harassing, or degrading;
 - 5) serves to impersonate any person or entity or misrepresent affiliation with any person or entity; or
 - 6) disparages or injures the reputation or goodwill of the Sponsor or any of its respective officers, directors, employees, products, or services.

D. Representations and Warranties: By entering the Sweepstakes, each entrant represents and warrants to the Sponsor that:

- i. The entrant’s entry meets all of the requirements in this Section 3;
- ii. The entrant meets all the eligibility requirements for the Sweepstakes; and
- iii. The entrant has complied with these Official Rules and all applicable laws in entering and participating in the Sweepstakes.

4. RANDOM DRAWING: On or about November 1, 2026, the Administrator will randomly select

one hundred (100) potential winners from all eligible entries received during the Sweepstakes Period ("Random Drawing") and the potential winners will be notified via email within two (2) days of this date (a "Prize Notification"). Each winner is considered a potential winner pending verification of his/her eligibility and compliance with the Official Rules.

5. PRIZES, APPROXIMATE RETAIL VALUE ("ARV"), AND ODDS OF WINNING:

A. Prizes (100): Each "Prize" is one (1) Chomps Snack Bearer Kit, including a branded cosmetic kit, 120 Chomps sticks, and assorted wellness items which may include but are not limited to undereye patches, lip gloss, deodorant, face spray, and mints. No more than one hundred (100) prizes will be available in the Sweepstakes. The ARV of each Prize is \$469.46.

B. Total ARV: The total ARV of all available Prizes in the Sweepstakes is **forty-six thousand nine hundred forty-six dollars (\$46,946 USD)**.

C. Odds of Winning: The odds of winning a Prize depend on the total number of eligible entries received during the Sweepstakes Period.

D. General: All Prize sizes, styles, and flavors determined by Sponsor in its sole discretion. In no event will more Prizes than are stated in these Official Rules be awarded. If, for any reason, more Prize notifications are sent (or more claims are received) than the number of Prizes offered, as set forth in these Official Rules, Sponsor reserves the right to award the intended number of Prizes through a random drawing from among all eligible Prize claims received. Limit of one (1) Prize per person/e-mail address. Prizes are non-transferable and no Prize substitution or exchange will be allowed, except by Sponsor, who reserves the right to substitute a prize of equal or greater value in case of unavailability of a Prize or force majeure. Each winner shall be solely responsible for payment of any and all applicable federal, state, and local taxes for any Prize won. All other costs and expenses not expressly set forth herein shall be solely the winner's responsibility. An IRS form 1099 and other tax-related forms and documents may be issued by Sponsor if required by law. The Sweepstakes Entities shall not be held responsible for any delays in awarding a Prize for any reason. If after a good-faith attempt Sponsor is unable to award or deliver a Prize, the Prize may not be re-awarded. Prizes are awarded "as is" without any warranty or guaranty of any kind, either express or implied, including but not limited to, the implied warranties of merchantability, fitness for a particular purpose or non-infringement. To the extent that prize elements are provided by third-party providers, winner agrees to look solely to applicable prize providers with respect to any claims, losses, or disputes in connection therewith. All properly claimed prizes will be awarded provided a sufficient number of eligible entries are received, but under no circumstances will more than the advertised number of prizes be awarded.

6. HOW TO CLAIM A PRIZE: Potential winners may be subject to verification of identity and/or eligibility and compliance with these Official Rules (in a form acceptable to the Sponsor including, without limitation, government issued photo identification): (i) for the purposes of verifying an individual's eligibility to participate in this Sweepstakes; (ii) for the purposes of verifying the eligibility and/or legitimacy of other information for the purposes of this Sweepstakes; and/or (iii) for any other reason the Sponsor deems necessary, in its sole and absolute discretion, for the purposes of administering this Sweepstakes in accordance with the Sponsor's interpretation of the letter and spirit of these Official Rules. Failure to provide

all required information within the stated time period may result in forfeiture of winner's right to claim a Prize and may result in the Prize being awarded to an alternate winner, if time permits. Sponsor and Administrator shall have no liability for any Prize Notification that is lost, intercepted, or not received by a potential winner for any reason. Sponsor will attempt to mail each Prize to the verified winner within 6 – 8 weeks from verification of winner's eligibility. All prizes will be sent to the physical address provided by the entrant upon registration. If a potential winner is found to be ineligible, is not in compliance with these Official Rules, declines to accept the Prize, or any winner notification is returned as undeliverable or the potential winner fails to respond to a winner notification or return all required forms within the timeframe specified in such winner notification, the Prize may be forfeited. If a Prize is forfeited for any reason, it may be awarded to an alternate potential winner, at the Sponsor's sole and absolute discretion, selected at random from the remaining pool of eligible entries received during the Sweepstakes Period, time permitting. Sponsor may successively attempt to contact up to three (3) potential winners in accordance with such procedure, and if there is still no confirmed winner of a Prize after such attempts have been made, Sponsor may announce an alternate means for awarding that Prize. Prizes are not transferable and include only the items specifically listed as part of each Prize. No substitution or cash equivalent of Prize is permitted except at the sole discretion of the Sponsor. If a Prize, or any portion thereof, cannot be awarded for any reason, Sponsor reserves the right to substitute the Prize or portion thereof with another prize of equal or greater value. Any portion of a Prize not accepted by a winner will be forfeited. Federal, state, and local taxes on a Prize and any expenses relating to the acceptance of and use of a Prize not specified herein are the responsibility of the winner. ARVs are as of the time these Official Rules were printed and the value of a Prize may fluctuate. A winner is not entitled to any difference between the ARV and the actual value of the Prize at the time the Prize is awarded. All other costs and expenses not expressly set forth herein shall be solely the winner's responsibility. The Sweepstakes Entities shall not be held responsible for any delays in awarding a Prize for any reason. Each Prize will only be awarded to a verified winner.

7. RELEASE AND LIMITATION OF LIABILITY:

A. Release and Indemnity: By participating in this Sweepstakes, entrants agree that the Sweepstakes Entities and each of their respective affiliates, subsidiaries, representatives, consultants, contractors, legal counsel, advertising, public relations, promotional, fulfillment and marketing agencies, website providers and each their respective officers, directors, stockholders, employees, representatives, designees and agents ("Released Parties") are not responsible for any and all liability for any damages, injuries, injuries or losses of any kind to person(s), including death, or property, arising directly or indirectly from the acceptance, possession, misuse or use of a Prize. Entrants agree to indemnify, defend, and hold harmless the Released Parties from any and all liability arising out of or relating in any way to entrant's participation in the Sweepstakes and to release all rights to bring any claim, action or proceeding against the Released Parties arising out of participation in the Sweepstakes, use of the Website(s), or receipt or use of any Prize, including but not limited to (i) lost, late, incomplete, stolen, misdirected, postage due or undeliverable e-mail notifications, telephone calls, or postal mail; (ii) any computer, telephone, satellite, cable, network, electronic or Internet hardware or software malfunctions, failures, connections, or availability; (iii) garbled, corrupt or jumbled transmissions, service provider/Internet/Website/UseNet accessibility, availability or traffic congestion; (iv) any technical, mechanical, printing or typographical or other error; (v) the incorrect or inaccurate capture of registration information or the failure to capture, or loss of, any such information; (vi) any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, technical error, theft or destruction

or unauthorized access to the Website; (vii) any injury or damage, whether personal or property, to entrants or to any person's computer related to or resulting from participating in the Sweepstakes and/or accepting a Prize; and (viii) entries that are late, forged, lost, misplaced, misdirected, tampered with, incomplete, deleted, damaged, garbled or otherwise not in compliance with the Official Rules. Further, the Sweepstakes Entities are not responsible for any undelivered telephone calls, messages or e-mails, including without limitation, e-mails that are not received because of an entrant's privacy or spam filter settings that may divert any winner notification or other Sweepstakes related e-mail to a spam or junk folder.

- B. Waiver:** By entering the Sweepstakes, each entrant agrees: (i) to be bound by these Official Rules, including entry requirements; (ii) to waive any rights to claim ambiguity with respect to these Official Rules; (iii) to waive all of his/her rights to bring any claim, action or proceeding against any of the Released Parties in connection with the Sweepstakes; and (iv) to forever and irrevocably agree to release and hold harmless each of the Released Parties from any and all claims, lawsuits, judgments, causes of action, proceedings, demands, fines, penalties, liability, costs and expenses (including, without limitation, reasonable attorneys' fees) that may arise in connection with: (a) the Sweepstakes, including, but not limited to, any Sweepstakes-related activity or element thereof, and the entrant's entries, participation or inability to participate in the Sweepstakes; (b) the violation of any third-party privacy, personal, publicity or proprietary rights; (c) acceptance, attendance at, receipt, travel related to, participation in, delivery of, possession, defects in, use, non-use, misuse, inability to use, loss, damage, destruction, negligence or willful misconduct in connection with the use of a Prize (or any component thereof); (d) any change in the prizing (or any components thereof); (e) human error; (f) any wrongful, negligent, or unauthorized act or omission on the part of any of the Released Parties; (g) lost, late, stolen, misdirected, damaged or destroyed prizing (or any element thereof); or (h) the negligence or willful misconduct by entrant.
- C. Disqualification:** Sponsor reserves the right in its sole discretion to disqualify any person it suspects or finds: (i) to have tampered with the entry process or the operation of the Sweepstakes; (ii) to be acting in a disruptive manner, or with the intent to annoy, abuse, threaten or harass any other person; (iii) to display behavior that will bring such winner or the Released Parties into disgrace (e.g., including but not limited to, a person committing acts of moral turpitude, and/or allegations or convictions of any crime); (iv) to have provided inaccurate information on any documents submitted in connection with the Sweepstakes; or (v) to be acting in violation of these Official Rules. ANY VIOLATION OF THESE OFFICIAL RULES BY A WINNER WILL RESULT IN SUCH WINNER'S DISQUALIFICATION AS A WINNER OF THE SWEEPSTAKES AND ALL PRIVILEGES AS A WINNER WILL BE IMMEDIATELY TERMINATED.
- D. Force Majeure:** If, for any reason, the Sweepstakes is not capable of running as planned, or the integrity and or feasibility of the Sweepstakes is severely undermined by any event beyond the control of Sponsor, including but not limited to fire, flood, epidemic, earthquake, explosion, labor dispute or strike, act of God or public enemy, satellite or equipment failure, riot or civil disturbance, war (declared or undeclared), terrorist threat or activity, or any federal, state or local government law, order, or regulation, order of any court or jurisdiction, infection by computer virus, unauthorized intervention, technical failures or other cause not reasonably within the control of Sponsor (each a "Force Majeure" event or occurrence), Sponsor reserves the right, at its sole and absolute

discretion, to abbreviate, cancel, terminate, modify or suspend the Sweepstakes and/or proceed with the Sweepstakes, including the selection of winners in a manner it deems fair and reasonable, including the selection of winners from among eligible entries received prior to such cancellation, termination, modification or suspension without any further obligation provided a sufficient number of eligible entries are received. If Sponsor, in its discretion, elects to alter this Sweepstakes as a result of a Force Majeure event, a notice will be posted at the Website.

- 8. DISPUTES:** AS A CONDITION OF ENTERING THE SWEEPSTAKES, ENTRANT AGREES THAT: 1) UNDER NO CIRCUMSTANCE WILL ENTRANT BE PERMITTED TO OBTAIN AWARDS FOR, AND ENTRANT HEREBY WAIVES ALL RIGHTS TO CLAIM, PUNITIVE, INCIDENTAL, CONSEQUENTIAL OR ANY OTHER DAMAGES, OTHER THAN FOR OUT-OF-POCKET EXPENSES; 2) ALL CAUSES OF ACTION ARISING OUT OF OR CONNECTED WITH THE PROMOTION, OR PRIZES AWARDED, WILL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION; AND 3) ALL CLAIMS, JUDGMENTS, AND AWARDS WILL BE LIMITED TO ACTUAL OUT-OF-POCKET COSTS INCURRED, BUT IN NO EVENT WILL ENTRANT BE ENTITLED TO RECEIVE ATTORNEYS' FEES OR OTHER LEGAL COSTS. SOME JURISDICTIONS DO NOT ALLOW FOR LIMITATIONS ON THE ABILITY TO PURSUE CLASS ACTION REMEDIES, OR CERTAIN KINDS OF DAMAGES, AND SO THESE LIMITATIONS MAY NOT APPLY TO YOU. THIS SWEEPSTAKES IS GOVERNED BY, AND WILL BE CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF ILLINOIS, AND THE FORUM AND VENUE FOR ANY DISPUTE SHALL BE IN COOK COUNTY, ILLINOIS. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN COOK COUNTY, ILLINOIS, AND ENTRANTS CONSENT TO THE MANDATORY AND EXCLUSIVE JURISDICTION OF SUCH COURTS WITH RESPECT TO ANY SUCH LEGAL PROCEEDINGS.
- 9. USE OF PERSONAL INFORMATION:** Any entry information (including personal data) collected from the Sweepstakes shall be used in a manner consistent with the consent given by entrants at the time of the entry, with these Official Rules, Sponsor's privacy policy, available at: <https://chomps.com/pages/privacy-notice>, and the mobile messaging section of the terms of service on the Website. All personal information collected from the Sweepstakes (including without limitation, an entrant's name, biographical data, and city and state of residence) may be used for the administration of the Sweepstakes. Except to the extent prohibited by applicable laws, each winner grants to Sponsor and each of its respective designees the right to publicize such winner's name and address (city and state/province of residence), photo (if provided), and prize information in connection with the Sweepstakes, in any media now known or hereafter devised, throughout the world, in perpetuity, without additional compensation or consideration, notification or permission.
